- 1. Handling chains and rods and driving stakes at the direction of the head of the party;
- 2. Cutting brush or performing necessary clearing away duties as required to make the survey;
- 3. Assisting the Surveyman in keeping notes or performing any other duties as directed by him;
- 4. Transporting the instruments to and from the job; assembling and disassembling them, as directed; maintaining all equipment in clean and workable condition;
- 5. Copying records at the Court House, as instructed;
- 6. Driving Company truck or car for transportation of the field party and its equipment; and
